SDSU currently offers education programs including Early Childhood Education (B.S.) - Birth to 8 Specialization, Early Childhood Education (B.S.) - Cooperative Elementary Education Program with DSU, and various secondary education majors and specializations. The proposed Elementary Education major supports the mission of SDSU as provided in SDCL 13-58-1: Designated as South Dakota's Land-grant University, South Dakota State University, formerly the State College of Agriculture and Mechanical Arts, located at Brookings SD, in Brookings County, shall be under the control of the Board of Regents and shall provide undergraduate and graduate programs of instruction in the liberal arts and sciences and professional education in agriculture, education, engineering, home economics, nursing and pharmacy, and other courses or programs as the Board of Regents may determine. In addition, the B.S. in Elementary Education will align with the South Dakota State University's mission and strategic plan Imagine 2023: Aspire. Discover. Achieve. As the state's land grant institution, SDSU's mission is to offer a rich academic experience in an environment of inclusion and access through inspired, student-centered education, creative activities and research, innovation and engagement that improve the quality of life in South Dakota, the region, the nation and the world. Specifically, the new program aims to achieve excellence through transformative education. The new program will support strategic goal 1 by increasing the number of accredited programs and developing and growing high-quality and distinct academic programs designed to meet the needs of diverse students and market demands.

There are eleven educator preparation programs (EPP) in South Dakota that train teachers and contribute to building the critically needed workforce of educators. South Dakota State University is the only institution of 11 teacher training programs that does not offer a B.S. degree in Elementary Education, which would allow SDSU to recommend these students to the SD Department of Education for certification as an elementary teacher. Due to current limitations on program offerings (i.e., elementary education), SDSU students who wish to become certified elementary education teachers must enroll in an extended and prescriptive cooperative program between SDSU and DSU. Interested students must first pursue a degree in Early Childhood Education (ECE) offered by SDSU and subsequently enroll in the DSU cooperative arrangement to become a credentialed elementary teacher. In doing so, SDSU students are required to complete an additional 24 credit hours of elementary education and field placements managed by Dakota State University (DSU). B. What evidence suggests there is unmet student demand for the proposed program, or that the proposed program would attract students away from the existing program?

SDSU students who wish to become elementary teachers are disadvantaged having only one pathway that requires 141 hours (approximately 20-25 students annually). The additional credit hours mean a higher cost to SDSU students, a fifth year of college with DSU, delayed graduation, likely more debt, and an inability to join the South Dakota workforce in a timely manner.

12. What is the expected growth of the industry or occupation in South Dakota and nationally?

The immediate need for additional teachers, including elementary teachers, is evident nationally ^[6] ,

for elementary teachers is growing. The Bureau of Labor Statistics projects 4% job growth for
Elementary Education teachers from 2021-2031. About 120,300 openings for kindergarten and
elementary school teachers are projected each year, on average, over the decade.[10] At the state level,
the SDBOR Program Demand Gap Analysis (PDGA) projects 9.5% growth in Elementary Education from
2020-2030.[11] The PDGA also cites 373 annual openings in elementary education.[12] The South Dakota
Educator Preparation Programs (n=11) collectively produced 307 elementary education teachers in
2021.[13] Both the USDOE and SDDOE currently include Elementary Education (core subjects) and
Elementary (self-contained) as areas of shortage. [14, 15] Although the need for an increased number of
elementary teachers has become self-evident, current practices place significant barriers upon SDSU
students who wish to pursue a career and degree in elementary education. Current restrictions on
fundamental teacher training tracks unduly limit SDSU student choice, often require the completion of
additional credit hours, and serves to delay entry into the teaching workforce.

17. What evidence suggests there is interest from prospective students for this program at the university?

SDSU students wishing to become certified elementary education teachers must enroll in the Early Childhood Education (ECE) program and complete an additional 24 credit hours of elementary education and field placements managed by Dakota State University (DSU). The total credit hour requirement is currently 141 credit hours because students are required to complete course work for two endorsement areas (i.e., early childhood education and elementary education). With the proposed major, prospective elementary teachers, who already attend SDSU, would have the option to pursue their goal without being required to enroll in a cooperative program that leads to both early childhood education and elementary endorsements. Although some students may seek both endorsements, the many who do not are burdened with additional barriers as prescribed by the traditional cooperative arrangement between SDSU and Dakota State University. SDSU students who wish to serve as teachers in South Dakota s Elementary classrooms (approx. 25-35 annually) are disadvantaged by the current institutional arrangement. For SDSU students who are not discouraged away from their goals by the additional barriers, they must complete and pay for 141 credit hours rather than 120 and complete an additional fifth year of college with DSU to become endorsed as an elementary teacher. Currently these students must delay graduation, accumulate more debt, and their timeline to join the South Dakota workforce is extended. For reference, there are 15 SDSU students completing the cooperative program with DSU in the fall of 2022 and 19 anticipated for spring. Using a conservative calculation (resident, on-campus, DSU tuition rate), the SDSU student cohort will pay an additional \$210,273 annually for credit hours to earn an elementary teacher credential (e.g., 21 credits, 34 students, \$294.50 per credit hour).[27]

18. Are students enrolling in this program expected to be new to the university or redirected from existing programs at the university?

The university anticipates students entering this program will be redirected from current SDSU majors including Early Childhood Education (B.S.) - Cooperative Elementary Education Program with DSU, Human Development and Family Studies (B.S.), and other areas including exploratory studies.(d Tf Tw 17.

The College of Education and Human Sciences anticipates that approximately 20 students who currently are pursuing the Early Childhood Education (B.S.) Cooperative Elementary Education Program with DSU would opt to pursue an elementary education only baccalaureate degree. The Human Development and Family Studies (B.S.) currently has an enrollment of 191. It is anticipated that approximately 20 students would opt to pursue an elementary education only baccalaureate degree. The Exploratory Studies program currently has an enrollment of 133 with 63 students enrolled in the education, social sciences, and management track. It is anticipated that approximately 20 students would opt to pursue an elementary education only baccalaureate degree. Incoming SDSU students who previously did not have the option to elect elementary education are expected to enroll. As the option becomes known, the university would expect an additional 40 new SDSU students annually at year 6.
